Sub: Ammonia-Urea Fertilizer Project in District Gorakhpur (UP) by M/s Hindustan Urvarak and Rasayan Limited - Amendment in Environmental Clearance - reg.

Sir,

This has reference to your proposal No. IA/UP/IND2/54269/2016 dated 9th January, 2018 on the above subject matter.

2. The Ministry had earlier granted environmental clearance vide letter dated 31st July, 2017 to the project 'Ammonia-Urea Fertilizer Project (Ammonia-2200 MTPD; Urea-3850 MTPD)' in District Gorakhpur (Uttar Pradesh) in favour of M/s Hindustan Urvarak and Rasayan Limited (HURL).

3. The project proponent has sought amendment in the said environmental clearance for removing one of the specific conditions stipulated therein at para 10 A(ix), quotes -

".....The ESC plan will include following activities:

(a) *Setting up of a Multi-Specialty Hospital with free of cost treatment for residents of local villages located within 5 km radius of the plant".*

It has been informed that the Multi-speciality hospital being one of the high expenditure item of the project cost, shall involve enormous financial implications and thus adverse impact on economic viability and bankability of the project.

4. On examination of the proposal in the Ministry, it has been decided to delete the specific condition mentioned above and accordingly amendment in the environmental clearance dated 31st July, 2017 to that extent, with all other terms and conditions stipulated therein remain unchanged.

5. This issues with approval of the competent authority.
