EXPRESSION OF INTEREST - NOTICE FOR EMPANELMENT

Sub: Expression of Interest (EOI) for empanelment of vendors for supply of Seaweed (Liquid) – Sargassum tenerrimum 10% and Seaweed (Granule) – Sargassum tenerrimum 2% in HURL's "APNA" brand in states of Uttar Pradesh, Rajasthan, Punjab, Haryana, Madhya Pradesh, West Bengal, Bihar, Odisha, Jharkhand, Assam, Chhattisgarh, Jammu & Kashmir, Himachal Pradesh, Maharashtra and Uttarakhand.

Hindustan Urvarak & Rasayan Limited (HURL), a joint venture company of Coal India Limited, NTPC Limited and Indian Oil Corporation Limited, Fertilizer Corporation of India Limited and Hindustan Fertilizer Corporation Limited, has set up Natural Gas based Fertilizer Complexes (Ammonia-Urea) of 2200 MTPD Ammonia and 3850 MTPD Urea each at Gorakhpur (Uttar Pradesh), Barauni (Bihar) and Sindri (Jharkhand).

HURL intends to expand its product portfolio (other than Urea) to offer full basket of bulk and non-bulk fertilizers for catering to various needs of Indian farmers and farming community focusing on balanced nutrients. To achieve the same, HURL intends to empanel various vendors (MANUFACTURERS only) for the supply of **Seaweed (Liquid) – Sargassum tenerrimum 10% and Seaweed (Granule) – Sargassum tenerrimum 2% in HURL's "APNA" brand in states of Uttar Pradesh, Rajasthan, Punjab, Haryana, Madhya Pradesh, West Bengal, Bihar, Odisha, Jharkhand, Assam, Chhattisgarh, Jammu & Kashmir, Himachal Pradesh, Maharashtra and Uttarakhand.**

The pre-qualified vendors would be eligible for participating in the future tenders to be invited by HURL subsequently for procurement of **Seaweed (Liquid) – Sargassum tenerrimum 10% and Seaweed (Granule) – Sargassum tenerrimum 2% in HURL's "APNA" brand in states of Uttar Pradesh, Rajasthan, Punjab, Haryana, Madhya Pradesh, West Bengal, Bihar, Odisha, Jharkhand, Assam, Chhattisgarh, Jammu & Kashmir, Himachal Pradesh, Maharashtra and Uttarakhand** through e-tendering.

Applications are invited from vendors (MANUFACTURERS only) for Supply of **Seaweed (Liquid) – Sargassum tenerrimum 10% and Seaweed (Granule) – Sargassum tenerrimum 2% in HURL's "APNA" brand in states of Uttar Pradesh, Rajasthan, Punjab, Haryana, Madhya Pradesh, West Bengal, Bihar, Odisha, Jharkhand, Assam, Chhattisgarh, Jammu & Kashmir, Himachal Pradesh, Maharashtra and Uttarakhand**, who meet the pre-qualification criteria and other requirements detailed in the empanelment documents. Annexure 2 is merely indicative and can increase or decrease depending on the requirement of HURL based on season, crop, economics of products and climatic conditions at that time. HURL requirement can increase by 10% to 15% or even more annually for the next 2 FYs.


The Instruction to Bidders & General Conditions of Contract (GCC) shall be issued along with the tender for procurement to be issued separately.
