- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. - 4. #### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

Bidder shall submit documents required against Pre-Qualification Crite ria (PQC) along with Technical bid for evaluation. HURL, by the examin ation of Techno-Commercial Bid, will determine to its satisfaction whet her the participating bidders are qualified to satisfactorily perform the contract in terms of Pre- Qualification Criteria stipulated in "Eligibility Criteria:1717073163.pdf" of tender document section Additional Qualification/Data Required.

An affirmative determination of meeting the Pre- Qualification Criteria

**Contract period :** The Contract Period shall be for a period of Two (02) ye ars from the date of issue of LOI/WO/LOA as certified by EIC. The contract may further be extended upto One year (12 months) as needed by HURL on the same rates, terms and conditions and subject to the Contractor's p erformance. However, clearance for continuation of contract shall be give n on month to month basis depending upon the job requirement and the C ontractor's performance and at the sole discretion of HURL.

er from the Owner, the contractor shall furnish the Contract Performance Guarantee (CPG), if applicable, for the due performance of the Contract for the amount equivalent to Five percent (05%) of the Contract Price with an initial validity up to ninety (90) days beyond the completion date for work plus defect liability period (if any), for due performance of the Contract(s)/ Order(s).

**Signing of Contract Agreement:** The successful tenderer / bidder shall be required to execute a contract agreement on non-judicial stamp pa per in the prescribed proforma (enclosed in Annexure) with the Compa ny with in 30 (thirty) days of the issue of the work order of the same for carrying out the work according to the general and special conditions of contract specified in the Tender Document.

**Fuel Charges :** Fuel charges shall be paid on monthly basis at a mile age of 10 KM per Ltr. for Innova Crysta AC Vehicle and 12 KM per Ltr. for Sc orpio AC Vehicle based on the actual run of vehicle in a particular month, d uly certified by HURL officer in charge or Controlling officer. The above vehicle mileage has been considered for running of vehicle along with AC. Cost of diesel will be reimbursed by HURL to the agency on actual basis in their monthly RA bill based on diesel rate applicable at the Indian Oil/BPCL/HPCL out let nearest to the HURL Sindri Project Office.

**Wages Compliance:** The successful bidder will be responsible for complia nce of all statutory provisions as per the Central Minimum wage act, Provid ent Fund, Bonus act and Employees State Insurance and any other mandat ory provisions of labour law in respect of the persons deployed by Contract or for this work and take comprehensive insurance covering third party risk as applicable for commercial vehicles. In addition to above, the contractor shall also arrange for workmen compensation insurance policy for the vehic le driver to cover any untoward incident while on duty.

The driver salary shall be as per the Central Minimum Wages under Skilled Category at present. In case of revision of minimum wage in future the age ncy will have to comply the same with no cost to HURL.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-
