The agreement should be submitted on non-judicial stamp paper of Rupees One Hundred or appropriate value as per Stamp Act relevant to place of execution, duly signed on each page.
- b) Number of members in the consortium shall not exceed 3 (three) and one of the members shall be designated as the lead partner of the consortium.
