5. Technical Qualification:

<u>**5.1**</u> <u>**Technical Criteria**</u>: BIDDER must have satisfactorily completed the similar works* mentioned below during last 07 (Seven) years ending last day of the month previous to the one on which NIT is invited.

*Similar Works means: The bidder must have successfully completed operation and maintenance services of water supply networking system in large process industry. For above, job executed by bidder for its own plant / project cannot be considered as experience for the purpose of technical criteria evaluation. However, jobs executed for Subsidiary / Fellow subsidiary / Holding company will be considered as experience for the purpose of technical criteria evaluation subject to submission of tax paid invoice (s) duly certified by Statutory Auditor of the Bidder towards payments of statutory tax in support of the job executed for Subsidiary / Fellow subsidiary / Holding company.

- <u>5.1.1</u> As a documentary proof, the bidder shall submit attested photo copies of the following Documents-

Technical department may reject the bid if make/model is not found as per said criteria.

5.3 Commercial Criteria:

<u>5.3.1.</u> The Bidder must have executed Similar Works * during last seven (07) years ending last day of the month previous to the one on which NIT is invited, with minimum work order (s) as per below:

One completed work with contract value not less than INR 41.86 Lakhs

Two completed works each with contract value not less than INR 26.16 Lakhs
OR

Three completed works each with contract value not less than INR 20.93 Lakhs

As a documentary proof for above, the bidder shall submit attested photo copies of the documents as specified at clause no. 5.1.1 of Technical Criteria.

- <u>5.3.2</u> Average Annual financial turnover during last three (03) financial years i.e. FY 2018-19, 2017-18 & 2016-17 of the bidder meeting the requirement as per clause above experience criteria should be at least INR 15.7 Lakhs.
- <u>5.3.3</u> Net Worth of the Company should be positive during the last financial year ending 31st March 2019.
- 5.3.4 The Bidder shall submit Solvency certificate not more than six months old from the date of issue of NIT from their Banker for a value not less than INR 20.93 Lakhs or minimum credit ratings of "A" from ICRA/CRISIL etc OR equivalent reputed institutions, OR financing / unutilized credit limits from bank of value not less than INR 20.93 Lakhs valid as on date of issue of ITB.

To meet the criteria (5.3.2 &5.3.3) above, bidder shall submit Audited Annual Statements (Balance Sheet and Profit & Loss account) of the company for three (3) financial years i.e. FY 2018-19, 2017-18 & 2016-17.

6. Evaluation of Bids:

- <u>6.1</u> Bids shall be scrutinized in terms of the provisions of the bidding documents. Full compliance to the complete provisions of the Bidding Documents and its subsequent Amendment(s) / Clarification(s) / Addenda / Errata if any, issued by the HURL shall be checked. Failure to comply with this requirement, the bid shall be rejected.
- <u>6.2</u> Technical and commercial bids shall be evaluated only for those bidders, whose EMD is found to be in order as per NIT requirement. EMD submitted by bidder will be reviewed against its value, validity and issuing bank as per NIT requirement. If the EMD is not found in order with respect to NIT requirement, the bids may be rejected.
- <u>6.3</u> The PRICE BID shall be opened only of those bidders whose bids are found to be technically and commercially substantially responsive.
- <u>6.4</u> A substantially responsive Bid is one which conforms to all the terms, conditions and specifications of the Bidding Documents without material deviations or reservations or omissions for this purpose Owner defines the foregoing terms below:-
- (a) "Deviation" is departure from the requirement specified in the tender documents.
- (b) "Reservation" is the setting of limiting conditions or withholding from complete acceptance of the requirement in the tender documents.
- (c) "Omission" is the failure to submit part or all of the information or documentation required in the tender document.
- <u>6.5</u> Before taking up the financial comparison, arithmetical errors, if any found in the price bid, shall be corrected as follows
- (a) In case of any difference in the quoted percentage in Figures and in Words, the percentage quoted in words shall prevail.
- (b) In the event of discrepancy between prices quoted in words and figures, the description in words shall prevail.
- (c) In the event of an error occurring as a result of wrong extension of the unit rate and quantity, the unit rate shall be regarded as firm and extension shall be amended on the basis of the rate.
- (d) All errors in totaling in the amount column and in carrying forward totals shall be corrected.
- <u>6.6</u> In case a bidder does not fill up any amount and leaves it blank or writing 'N/A' or put '- 'against any item of Price Schedule, it shall be deemed that cost of such item (s) is included in other item by the bidder elsewhere in the quoted price. Incomplete Price Schedule may result into rejection of bid
- 6.7 If the Bidder does not accept the corrections/adjustment as mentioned at 6.5 above, its Bid will be rejected and EMD shall be forfeited.

- 6.8 The financial comparison for selection of Lowest (L-1) Bidder / Contractor shall be done based on the total derived price and the arithmetical corrections/adjustment as mentioned above. The aggregate amount of supply of consumable items and O&M services will be worked out as total derived price of all items of BOQ, shall be considered for evaluation and award.
- <u>6.9</u> The Owner will award the Contract to the successful Bidder whose Technical and Commercial bid has been determined to be substantially responsive and Price Bid to be the lowest evaluated Bid.
- <u>6.10</u> If Lowest (L-1) bidder quotes for manpower services (As mentioned in S.N. 1.02 of BOQ) lower than estimated amount of same then the bidder shall be asked to submit security deposit for manpower services as per following before award of contract -

Security deposit amount for manpower services = Estimated amount for manpower services (Estimate against S.N. 1.02 in BOQ sheet) — Quoted amount by the bidder (Quoted figure against S.N. 1.02 in BOQ sheet)

6.11 The total / unit price of each consumable item of supply as mentioned in SOR shall be derived from estimated amount for that item by multiplying it with a factor i.e. (quoted amount in price bid for supply of consumable items - estimated amount mentioned in price bid for consumable items) / (estimated amount mentioned in price bid for consumable items).

7. Bid Submission:

Bids shall be submitted online only at CPPP website: https://eprocure.gov.in/eprocure/app. Tenderer/Contractor is advised to follow the instructions provided for online submission of bids. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

- 8. Not more than one tender shall be submitted by one contactor or contractors having business relationship. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.

1.0 REGISTRATION

- 1.1 Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: https://eprocure.gov.in/eprocure/app) by clicking on the link "Online bidder Enrollment" on the CPP Portal which is free of charge.
- 1.2 As part of the enrollment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 1.3 Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 1.4 Upon enrollment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
- 1.5 Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 1.6 Bidder then logs in to the site through the secured log-in by entering their user ID /password and the password of the DSC / e-Token.

2.0 SEARCHING FOR TENDER DOCUMENTS

- 2.1 There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. - 2.3 The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

3.0 PREPARATION OF BIDS

- 3.1 Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 3.2 Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3.3 Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 3.4 To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or ''Other Important Documents'' area available to them to upload such documents. 4.0 SUBMISSION OF BIDS:

- 4.1 Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 4.2 The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 4.3 Bidder has to select the payment option as "offline" to pay the tender fee / EMD as applicable and enter details of the instrument.

- 4.4 Bidder should prepare the EMD as per the instructions specified in the tender document. The original should be posted/couriered/given in person to the concerned official, latest by the last date of bid submission or as specified in the tender documents. The details of the DD/any other accepted instrument, physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. - 4.5 Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. If the price bid has been given as a standard BOQ format with the tender document, then the same is to be downloaded and to be filled by all the bidders. - 4.6 The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
