- 3.0 EMD/Bid Security shall be submitted through RTGS/NEFT by the stipulated bid submission closing date and time. Any bid without an acceptable Bid Security (if applicable) shall be treated as non- responsive by the employer and shall be liable for rejection.
- **4.0** MSE bidders are exempted from submission of EMD as per provisions in the Tender Documents.
