- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 3. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents
- 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
- 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost: or
- 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.
- 6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

Pre-Qualification Criteria (PQC): PQC against this tender are uploa ded in *Buyer Added Bid Specific ATC* of tender document.

Bidder shall submit documents required against Pre-Qualification Criteria (P QC) along with Technical bid for evaluation. HURL, by the examination of T echno-Commercial Bid, will determine to its satisfaction whether the partici pating bidders are qualified to satisfactorily perform the contract in terms of Pre- Qualification Criteria stipulated in tender document section **Buyer Added Bid Specific ATC**.

An affirmative determination of meeting the Pre- Qualification Criteria will be a prerequisite for further evaluation of Techno-Commercial bid. A negative determination will result in rejection of the Bidder's Techno-Commercial Bid in which event HURL will not open the Price Bid of the concerned bidder.

Note - Past Experience of Similar Services as stipulated in S.N. 1 of Pre-Qualification Criteria uploaded in tender bid document section Buyer Added Bid Specific ATC shall supersede the clause 5 - "Past Experience of Similar Services" mentioned on page 3 of tender bid document.

Price Bid Break up after Reverse auction- The successful bidder ne eds to submit the price bid break up in line with price quoted by him in re verse auction. Price bid break up shall must be as per the format uploade d with tender document.

The bidder shall ensure that their contractor service charges including G ST on manpower services shall not be less than 3.85%.

In case the successful bidder(s) fail(s) to submit the final price bid break up or the break up given by bidder does not match with total offered price, then HURL will be at liberty to place order by proportionately reducing the component rates on basis of the breakup of the e-auction bid submitted by the successful bidder along with their initial offer and the same will be binding on the successful bidder. In that case, if contractor service charges is coming lower than 3.85% in deriving rate break-up in same proportion explained above then their price break-up will be derived by kee ping contractor service charges as 3.85% and other item rates to be reduced in proportion of total balance amount reduced from their initial price bid to offered RA price.

Contract period:

The Contract Period shall be for a period of one (01) year from the date of effective date of contract as certified by EIC. The contract may further be extended upto Six months (6 months) as needed by HURL on the same rat es, terms and conditions and subject to the Contractor's performance. Ho wever, clearance for continuation of contract shall be given on month to m onth basis depending upon the job requirement and the Contractor's perfo

rmance and at the sole discretion of HURL.

Contract Price:

The total contract price shall consist of followings,

- (1) **Total price** as quoted by successful bidder for all the items mentione d in Schedule of Rates (SOR) and BOQ. Quoted rate shall remain firm an d subject to no escalation whatsoever during the contractual completion period including extended period, if any.
 - In case of revision of minimum wages by central govt. (Labour departm ent) during the contract period, the increase amount shall be payable/reimbursable by HURL including its implication on statutory be nefits i.e. PF, ESI, Bonus, Retrenchment & EL etc. along with GST as applicable. However, contractor profit/ Service Charges per man day in figure will not increase on escalated wages and shall remain firm for the contract period and its extended period.
- (2) **Estimated Cost of Petrol** for Grass Cutting Machine, Chain: Estimat ed quantity of 1548 Litres shall be considered and contract amount of p etrol shall be derived as per the petrol rate (prevailing at IOCL/BPCL /H PCL outlet nearest to the HURL Sindri Project office) as on the date after the financial bid evaluation and before date of award as decided by HU RL and Estimated petrol quantity of 1548 Liter.
- (3) A separate SAP PO will be issued as per above calculated contract pric e consisting of both above parts.

PBG: Within thirty (30) days of the receipt of Purchase Order/Service Orde r from the Owner, the contractor shall furnish the Contract Performance Gu arantee (CPG), if applicable, for the due performance of the Contract for the amount equivalent to Five percent (05%) of the Contract Price with an initial validity up to ninety (90) days beyond the completion date for work plus defect liability period (if any), for due performance of the Contract(s)/ Orde r(s).

Signing of Contract Agreement: The successful tenderer / bidder shall be required to execute a contract agreement on non-judicial stamp paper of Rs.500 in the prescribed proforma (enclosed as Annexure-11 to Section VI i.e., Forms and Procedures) with the Company with in 30 (thirty) days of the issue of the work order of the same for carrying out the work according to the general and special conditions of contract specified in the Tender Document.

Wages Compliance:

The successful bidder will be responsible for compliance of all statutory provisions as per the Central Minimum wage act, Provident Fund, Bonus act and Employees State Insurance and any other mandatory provisions of labour law in respect of the persons deployed by Contractor for this work.

- (iii) The contractor will insure all his personnel employed for the execution of the work against any personal injury that may be sustained as a result of the execution of the work. The contractor will present satisfactory evidence to the owner/consultant that such insurance is in force.
- (iv) The contractor shall be responsible for workman's compensation insurance / ESI scheme and all other statutory requirements in regard to the personnel in the contractor's employment.
